


Q4 2020 - BUSINESS REVIEW

Slight recovery in sales volumes

Consolidated Revenues

Q4 revenues reached MAD 2 773 million, or -1% compared to Q4 2019, and consolidated annual revenues for fiscal year 2020 amounted to MAD 11 012 million, representing a +6% increase vs. 2019.

Q4 2020 Capex reached MAD 269 million, or 61% less than Q4 2019.

Consolidated Debt

As of December 31st 2020, Net Debt (including outstanding leasing payement) recorded a decline of MAD 145 million, representing 47% of the permanent financing, vs. its level of 53% at December 31st 2019.
